RE : School Reopening (In Person Instruction / Hybrid Learning)

Public Health Order No. 2021-014 has been issued by the Navajo Nation government. Rough Rock Community School Inc. will follow the health order as received. The following conditions will be followed for each K12 academic sites beginning July 28, 2021 and until further notice.

1. In Person Learning: Rough Rock Community School is offering in person (face to face) instruction. Face to face instruction allows students to board the school bus daily and receive instruction from teachers. RRCS recommends the "face to face" feature so that all students receive instruction and students do not fall behind.
2. Hybrid learning: (Parent Option) Hybrid students will be viewing live instruction with streaming the classroom with teachers and students. Students must be prepared to attend class daily to participate in the live streaming. Students must log in to view the live instruction before classes start. Hybrid students who do not participate will be counted absent. The hybrid version leaves the responsibility on the students, parents, and guardians to ensure that their child attends/participates daily. Hybrid students will be dropped if absent for 10 consecutive days.
3. The first day of school will be begin July 28, 2021 (Wednesday). School buses will run their routes to each student's residence. Please have your child ready to board the school bus.
4. Academic teachers will be ready to receive students. Parents may drop off their child at the school location they are enrolled. School will be open Monday through Friday.
5. Classrooms are set up using the CDC guidelines: sneeze guards will be used for each student and teacher, hand sanitizers and face mask are available, and each student must social distance at all times when in school. Face mask is mandatory. Personal face mask should be washed daily.
6. All students and staff will be wearing their face mask at all times when school is in session. RRCS has a full-time school nurse who will be monitoring student and staff welfare.
7. Please talk to your child about following the rules when in school and when riding the school bus. Each student must wear their face mask on the school bus and during the entire school day. RRCS has face mask available for those students who may need a face mask.

8. Students must bring their laptop and chargers to school while attending school. Students will be using their lap tops in the classroom each day. This will require students to become responsible to take care of their lap top computers and chargers.
9. Meals: Students who attend school with the face to face learning will be receiving hot meals for breakfast and lunch. School cooks will be preparing fresh meals for students who attend school daily (in person).
10. Hybrid students will be receiving packaged meals. Hot meals will not be provided for hybrid students.
11. Residential Hall: The residential hall will open for both boys and girls (ages 6-18) on July 25, 2021 from 8am-5pm. Please bring your child to the residential hall during this time to register your child for the dormitory. Our dorms are fully staffed and have implemented the CDC guidelines to ensure the safety for your child. Residential students will be provided hot meals when enrolled in the residential hall.
12. Parents/guardians must fully complete the enrollment packet with updated cell phone/telephone numbers, contact information, addresses, and related. Call 928-728-3702.
13. RRCS supports and recommends that students from ages 12 and older be vaccinated to prevent the spread of COVID 19.
